Be safe on the water while you enjoy time with family and friends throughout the holiday season.



Boating Under the Influence

USCG

BUI is just as deadly as drinking and driving!

Did you know:

- A boat operator is likely to become impaired more quickly than a driver, drink for drink?
- The penalties for BUI can include large fines, revocation of operator privileges and serious jail terms?
- The use of alcohol is involved in about a third of all recreational boating fatalities? Every boater needs to understand the risks of boating under the influence of alcohol or drugs (BUI). It is illegal to operate a boat while under the influence of alcohol or drugs in every state. The Coast Guard also enforces a federal law that prohibits BUI. This law pertains to ALL boats (from canoes and rowboats to the largest ships) and includes foreign vessels that operate in U.S. waters, as well as U.S. vessels on the high seas.

Dangers of BUI

Alcohol affects judgment, vision, balance and coordination. These impairments increase the likelihood of accidents afloat for both passengers and boat operators. U.S. Coast Guard data shows that in boating deaths involving alcohol use, over half the victims capsized their boats and/or fell overboard.

Alcohol is even more hazardous on the water than on land. The marine environment motion, vibration, engine noise, sun, wind and spray accelerates a drinker's impairment. These stressors cause fatigue that makes a boat operator's coordination, judgment and reaction time decline even faster when using alcohol.

Alcohol can also be more dangerous to boaters because boat operators are often less experienced and less confident on the water than on the highway. Recreational boaters don't have the benefit of experiencing daily boat operation. In fact, boaters average only 110 hours on the water per year.

Alcohol Effects

Alcohol has many physical effects that directly threaten safety and well-being on the water.

When a boater or passenger drinks, the following occur:

- Cognitive abilities and judgment deteriorate, making it harder to process information, assess situations, and make good choices.
- Physical performance is impaired evidenced by balance problems, lack of coordination, and increased reaction time.
- Vision is affected, including decreased peripheral vision, reduced depth perception, decreased night vision, poor focus, and difficulty in distinguishing colors (particularly red and green).
- Inner ear disturbances can make it impossible for a person who falls into the water to distinguish up from down.
- Alcohol creates a physical sensation of warmth which may prevent a person in cold water from getting out before hypothermia sets in.

As a result of these factors, a boat operator with a blood alcohol concentration above .10 percent is estimated to be more than 10 times as likely to die in a boating accident than an operator with zero blood alcohol concentration. Passengers are also at greatly increased risk for injury and death - especially if they are also using alcohol.

Cooperative Charting: A Program for All Members

The Cooperative Charting Program of the United States Power Squadrons is conducted in close cooperation with the United States Army Corps of Engineers, the United States Coast Guard, and NOAA's National Geodetic Survey Division (NGSD). The program continues to be a major public service of USPS. As in the past, members supply important information to the above agencies so updates can be made to nautical charts and the National Survey Marker databases. The Aid-To-Navigation and Bridge Inspection programs support the USACE and Coast Guard in assuring waterways are properly marked and maintained. It is a great program to get members out on the water. The reporting requirements have been streamlined and it is easily completed online. The Cooperative Charting Committee maintains a Geodetic Program where members help to verify the accuracy of reference points established on the surface of the earth by local, state, and national agencies. Maintenance and preservation of these marks are of utmost importance to users of the net and to NGSD. Recognizing that many valuable geodetic marks are destroyed by construction, new roads, erosion, or other causes, our job is to locate each of these marks and report their condition together with any change in the directions needed to locate them. This is another great program in which squadrons/clubs can participate. You don't need a boat; just a willingness to search along roads and trails finding these markers. It is a program that brings out our members. We have been complimented by government leadership that our Cooperative Charting Program is recognized as an effective user-participation program. Try it!

Tales of a First Time Boat Owner

At a recent Squadron Executive Committee meeting I was trying to persuade some committee members to provide a profile for the upcoming issue of the Signal. There were no takers, but someone suggested that I write an article as a first-time boat owner so I have taken up the challenge.

After having visited the area for several years, we decided it would be a nice place to retire. In the autumn 2013 we purchased a home near beautiful Smith Mountain Lake. Our previous boating experience was very limited and we had never owned a power boat. My experience with power boating was limited to my taking the helm on a return trip to Fairahven in rough weather through Quik's Hole in the Elizabeth Islands when others onboard were too seasick.

We were at our new home, reading the paper one day, and saw a posting for a boating certification class hosted by the United States Power Squadron. We decided to take the class since we lived near the lake and might one day decide to rent or buy a boat. After the class was over, we were chatting with members of the Squadron and were introduced to what the Squadron was and their programs and social activities. Randy Stow and Art Cournoyer explained much about the United States Power Squadrons' function and some of the programs and activities they participated in. Thinking "exclusive yacht club" in the back of our minds, we held off joining. It was made clear to us that this was not an extravagant, exclusive "yacht club", but a reasonably priced, educational and safety oriented boating organization with a social component. After thinking about it, my wife and I joined the Squadron and began learning much about boating. One very valuable thing we learned though the Squadron was how to determine what type of boat was best suited for us.

Over the next few years we checked marinas and postings to locate a covered dock where we might keep a boat if we were to find a suitable one. Nothing was available anywhere near us. We knew trailering a boat was not an option that we wished to entertain. We knew trailering would limit the amount we would use that boat so therefore we would not consider that option. We did, however, keep watching the ads and looking online.

In October of last year, we struck a deal on an older 22.5' deck boat. Except for some blemishes in the upholstery and a few small dings, the boat is in good shape. We have been out on the lake many times with boater friends over the last few years and, if we had paid more attention to how we were getting where we were going and less to the beautiful scenery, we would be better at getting around the lake. We venture out a bit further each time we leave the dock and try to implement many of the



things that we learned through the United States Power Squadrons. One valuable lesson we have learned is that many folks using our lake really should take some of the courses provided by the United States Power Squadrons. We are thankful to the experienced boaters in the Smith Mountain Lake Sail and Power Squadron for helping us to become safer boaters.

I would add that waiting to purchase a boat has had the benefit of not having a lot of surprises in the costs involved. It is expensive and we knew that it would be going in, but it is a hobby, and most hobbies tend to be expensive. Hopefully we will be rewarded with the enjoyment of being able to get out on the lake more often when the urge hits us.

Surface Air Scuba System

Ever wanted to swim around your dock like a fish? How about retrieve that lost tool that dropped to the lake bottom under your boat dock? You could invest in scuba gear and compressed air tanks. But there is an alternative!

Introducing the *Hookah* system. (Breathing compressed air from an air compressor on your dock attached to a 60 foot air hose) See the photo of the components.

Last December I purchased the system and took scuba training which is strongly encouraged.

AND

Last week I tested this out on our O'Day 35 sailboat bottom. It was quite green. Judy turned on the compressor switch and I put on my dive mask and flippers and my weight belt, put the regulator in my mouth and I became a Frog Man.

I can only hold my breath for 30 seconds under water in a free dive but with this system, I was able to breath continuously underwater without having to surface repeatedly for air. I was able to clean the entire bottom of this boat in 25 minutes. It was really amazing but I caution, there is danger.

Do not expect me to be going into the boat cleaning business. I'm not. But this is more fun than a snorkel and much less hassle than scuba tanks.

Documentation and Registration

SHARKS IN THE WATER

I am using this catchy phrase to highlight what is happening in the area of boat documentation. Some of us have our boats documented with the USCG while others are registered with their states. In the case of USCG documentation there is a yearly renewal now changing to several years as a possibility. The SHARKS in the waters as my title alludes to, is about a company know as Marine Documentation Center (MDC). They are a 3rd party that will act for you to document and/or recertify your USCG Documentation, but are not affiliated at all with the USCG. Their prices are out of sight and downright untenable when compared to what USCG charges. The major problem is that on the internet if you simply type in USCG Documentation



it will give you several sites which direct you to MDC or other sites, but not USCG even though you have that in your request. You will need to scroll down past several selections to find one that is USCG only or call the number to USCG in Falling Waters, West Virginia. I am sure MDC has paid Google to ensure that they are always first in line for anyone who happens to log on looking for documentation services. This is not illegal, but immoral, in that several of the links all lead you to MDC.

As a 3rd party, they have direct access to your documentation number and data associated with it, which somewhat confirms that you have USCG on the phone. Such is not the case and after a few questions you arrive at one that tweaks your interest when they want the SSN of the owner and co-owner. I should have known right then that I was not talking to USCG (but in the heat of battle, my certification had expired over a month previously while I was in the hospital), but confused I continued. They are quick to respond and will take advantage of the situation allowing you to think you have USCG on the phone, should you be calling rather than surfing the net for USCG, which I should have done. Then comes the comments that all payments are non-refundable (that should have been another tweet, but still thinking I am talking to USCG, I continued) and confirmed a charge of \$750 for recertification and 5 years renewal.

That, in itself, should have been an electric charge to my system as to exactly whom I was speaking with. But I continued and immediately confirmed with my co-owner that in 2018 she had received a letter from them and she had signed on for 3 years of renewal. All the while, I am paying my yearly renewal with USCG receiving my renewal notice at least a month ahead of my expiration date. Covid could have disrupted the snail mail, along with receiving mail only once or twice a week. Thus, my expiration date passed, and now I needed to be legal. An immediate recall to MDC as to my request for cancellation where upon the same individual said all I needed to do was send an email that "I thought I was talking with USCG" and it would be canceled. True, but that non-refundable issue did not rear its head until several emails later when I asked for clarification of my cancelation and a refund to my credit card. I then called USCG in Falling Waters, West VA. I was informed that they had no affiliation with MDC and spend hours talking with members such as myself about the excessive expense they charge and to be honest, leave you hanging with; items like it takes 8-12 weeks to get your results. While on the phone, I gave my email to USCG and paid my \$81 for recertification. I got it in the mail within a week. I immediately called my Credit Card Company and complained about the charge. Ultimately, they helped me get a rebate, but even that took time. Lesson? Don't be duped by MDS.!

New Regulations to take effect 1/1/2023



Move Over Regulation

- ullet This is a new requirement and is similar to that requirement placed upon motor vehicles on the roads.
- When approaching or passing within 200 feet of any law-enforcement vessel or emergency services vessel that is displaying flashing blue or red lights, a boater shall slow to no wake speed so that the effect of the wake does not disturb the activities of law-enforcement personnel or emergency services.



Fire Extinguishers

The update to the Virginia requirement for fire extinguishers mirrors the new federal fire extinguisher regulation.

- This stipulates that boats model year 2018 or newer must carry 5B, 10B or 20B weight rated fire
 extinguishers.
- It also stipulates that fire extinguishers must not be expired.
- A fire extinguisher that is older than 12 years of the date of manufacturer is considered expired.

Clean, Drain, Dry

- This new regulation requires that boat operators clean any aquatic organisms or vegetation from the vessel, trailer, and equipment before departing the boating area.
- This regulation also requires boat operators to drain and make reasonable measures to dry bilge tanks, livewells, and ballast tanks before departing a body of water.



USCG recently sent out a letter stating that Motorized Personal Hydrofoils and Motorized Surfboards have been determined to be vessels and are therefore subject to all the laws and regulations pertaining to recreation vessels propelled by machinery.

The Potato - Part 2 of 3

Karl's Kitchen Korner



My least favorite potatoes are "French Fried" and "Hash Browned". I once had excellent "French Fries" in a city in central California. They were "typical looking" but crispy and thinner than usual, maybe 1/8 inch thick and 1/4 inch wide, and nicely seasoned. Not had any like them since. I eat French Fries because they usually accompany a sandwich but they are basically a way of conveying Ketchup. "Hash Browns" which usually go with breakfast are most frequently previously frozen, tasteless and mushy. See Part 1 for how I like breakfast eggs and potatoes.

Now for a couple of recipes for the "Star" of the dish. 1) Bacon Potato Stacks and 2) Shirred Eggs in Crispy Potato Cups. Both take some effort and practice to perfect.

Bacon Potato Stacks

Shirred Eggs in Potato Cups

Ingredients

2# Small Russet potatoes, thinly sliced.
8 slices of bacon, cooked and crumbled.
1 cup heavy whipping cream.
2 cloves of Garlic minced.
1 Tsp Kosher salt.
1 Tsp chopped fresh Thyme.
1/2 Tsp fresh ground black pepper.

1/8th Tsp ground nutmeg.

1/2 cup grated Pecorino cheese

Garnish: chopped fresh thyme.

Ingredients

2 medium russet potatoes.

2 Tsp salt divided.

4 Tbsp. butter, melted.

1/4 Tsp. freshly ground black pepper.

4 Eggs.

Mornay sauce for serving.

Directions

- Preheat oven to 375 degrees. Spray a 12-cup muffin pan with cooking spray and place on a rimmed baking sheet.
- Layer potatoes and bacon in prepared muffin tin beginning with potato and ending with bacon.
- In a small sauce pan, bring cream, garlic, salt, thyme, pepper, and nutmeg to a simmer over medium heat. divide cream mixture among muffin cups filling them almost to the top. Sprinkle with cheese.
- Finally bake until potatoes are fork tender, 30 35 minutes. remove from heat; let sit for about 5 minutes. Using a knife, loosen potato stacks and remove with aid of a fork. Garnish with thyme if desired.



Directions

- Preheat to 450 degrees F.
- Cut potatoes in half crosswise.
- Scoop out center (melon baller).
- Leave about 1/4 inch rim of potato (This is key). Slice off enough of the ends of the potatoes to prevent rolling over.
- Put potato cups in enough water to cover in pot; add 1 Tsp. salt; bring to a boil; cook for 5 minutes.
- Remove Potatoes from water to rest for another 5 minutes.
- Brush inside and out with butter.
- Place 1 or 2 Potato cups in custard cups or ramekins, scooped side up.
- Season inside with 1/2 Tsp salt and !/8 Tsp pepper.
- Bake in oven until golden brown, about 20 minutes.
- Reduce Temp to 350 degrees. Carefully break an egg into each of the potato cups and bake 5 6 minutes.
- Remove from oven; season with remaining salt and pepper. Serve with Mornay Sauce on top.

 $\pmb{Sauce:}$ 1 Tbsp. butter; 2 Tbsp. A-P flour; 1 cup milk; 1 bay leaf; 2 Tbsp. grated Swiss cheese; and 2 Tbsp. grated Parmesan cheese

Melt butter in pan; stir in flour and cook about 1-2 minutes. Whisk in milk and add bay leaf; cook 10 - 15 minutes; Remove bay leaf and whisk in the cheeses. Cook until melted


